
It is that time of year when we kick off the annual **NNCA/WMANNCA membership** renewal drive for the 2021-2022 membership year

PLANNING TO MEET A PANDEMIC: A NAVY NURSE IN UNCHARTED WATER Rose Perdue

In spring 2020, I relinquished my position as Director of Nursing Services at Fort Belvoir Community Hospital (FBCH), to begin preparing for retirement after 29 years as a Navy Nurse Corps Officer. Days before my departure, my Director "Commanding Officer" Captain Cindy Judy, asked me to assist in the fight against the COVID virus. I realized that I needed to be part of that effort and so I requested to stay on Active Duty.

Captain Judy assigned me as the COVID-19 Coordinator and liaison for all things pandemic related coming into the Command at Fort Belvoir Community Hospital (FBCH). Many commands from the Fort Belvoir Garrison to all the National Capital Area Military Treatment Facilities, had a nonstop and ever growing list of questions and concerns about how best to man, train and equip for the monumental challenges posed by the coronavirus. I started participating in an endless series of phone conferences and virtual meetings with people across many different disciplines to answer a wide array of complex questions: What is the hospital's position/advice on the barber shop, gym, commissary and exchange staying open? How do we protect service members who share common living spaces in the barracks? What locations on Post might we use to house healthcare workers in a surge? How should we protect an entire special forces unit?

I would filter what was coming in and get things to the right staff and I would also push out data back to the requesting party so we knew what was coming in and out of the Command and how that was impacting our staff. I spoke frequently and shared many references and stories with col-

leagues including retired RADM McCormick-Boyle who was establishing a COVID hospital in Buffalo, NY and with CAPT Dixie Aune, who was Naval Hospital Portsmouth's DNS. The Command leaders swung into action and with no additional staff established, reconfigured, and managed countless new requirements. We established a COVID-19 clinic with curbside clinical testing capabilities, a drive- thru pharmacy, and a temporary quarantine/isolation facility. We committed to outreach and provided transparent real-time community information and feedback.

As I once again contemplate retirement I am full of pride and gratitude for the opportunity to



serve. The vaccine distribution presents its own unique challenges, yet I know there are many ready to assume the watch. As my "extra" year comes to a close, I am ready to step ashore, but I will head directly to the nearest American Red Cross and sign up as a volunteer ... maybe I'll see you there and I look forward to continued service with all of you in this great association.

MEDICAL RESERVE CORPS VOLUNTEER—VACCINATION PROVIDER Christine Boltz

In early January after two notices from the Virginia Department of Health that volunteers were urgently needed for the COVID-19 vaccination campaign, I signed up to support the effort through Virginia's Medical Reserve Corps (MRC). After submitting my application, I began to investigate the training requirements. A new volunteer effort is similar to new employment, you need to pass a background check and complete training before being fully functional in a new role.

Training involved several courses related to volunteering with the Alexandria MRC to support and/or respond to emergencies that impact public health. Then there was the clinical training, the list is longer for those without routine vaccination experience in the last year. Similar to the military and most organizations, the training system is online, and coursework is self-paced. Once I heard my application was received, I began the training which took a few days to complete with the exception of the in person skills/competency check. After my background check cleared, I received word to come in to get my identification badge and a t-shirt, a signal, I was approved to sign up to support an event. Alert messages about event support, started, so I signed up for a vaccination event.

My first volunteer event, I was assigned as a vaccinator assistant as I was pending the skills/competency check by an Alexandria Health Department staff member outside of a vaccination

event. Being a vaccinator assistant was very help-ful to see how the operation works and understand better the expectations, it has been a bit since I worked in a clinical setting. The assistant works with a vaccinator and does nearly everything except give the vaccine and document the episode of care. The following week, along with several other new nurse volunteers, I completed my skills/competency check training. As a new volunteer, I may not always be assigned as a vaccinator, however I know I will not be standing outside directing traffic or patient flow.

Getting my vaccination at the location where I volunteer was a great experience. The patient perspective is always helpful, and it also reenforces why I volunteered. I have a nursing license; they need help and what else of greater importance am I doing. Being a vaccinator is the best job. There are a lot of other needed volunteer roles in the vaccination campaign process, such as call center operations and other support activities. I anticipate supporting vaccination efforts in Alexandria, VA once or twice a week as long as needed.
